

## Frequently Asked Questions

1. How much will I receive in tax credits for my donation? **You will receive tax credits for 90% of your contribution. The remaining 10% can be utilized as a tax deduction. For example, if you contribute \$3,500, then you will receive \$3,150 in state tax credits.**
2. How much will this cost up front? **Your award letter will request an out-of-pocket check. You will then receive a K-1 form to file with your taxes to receive a refund of 90% your contribution.**
3. Will Mountaintop Christian Academy receive all of the money that I donate? **Yes! MCA will receive 100% of funds as long as you designate our school on your joinder.**
4. What will my contribution accomplish at MCA? **100% of your contribution will go towards student scholarships. Your contribution makes it possible for students to attend our school.**
5. Do I need to re-apply yearly? **Yes! CPSF will contact you to re-apply.**

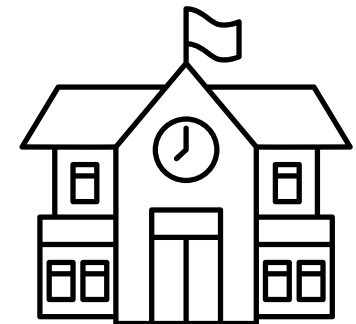

## Eligibility

Must be employed by or own a For Profit Company OR owns stock in a business that operates in Pennsylvania

For Couples Married Filing Jointly: One must be employed by or own a For Profit Company OR own stock in a business that operates in Pennsylvania

Pays at least \$3,500 in Pennsylvania state taxes

Earns at least \$115,000 in taxable income individually or if Married Filing Jointly



## Process



- Determine your PA tax liability. We recommend referring to your previous year's tax filing (Form PA-40 Line 12) or consulting an accountant.
- Sign a Joinder Agreement with Central Pennsylvania Scholarship Fund (CPSF). Be sure to designate MCA as your school of choice.
- Submit completed Joinder to our school, MCA.
- CPSF will send a letter confirming your awarded credits equalling 90% of your total contribution and requesting a check.
- Mail your check to CPSF within 60 days and 100% will be sent to our school.
- You will receive a K-1 form to file with your taxes that provides a tax credit.



## About CPSF

**Central Pennsylvania Scholarship Fund (CPSF)** was founded in 2015 with a passion to help more children in Pennsylvania receive a quality, private school education. CPSF is a charity that assists private schools in receiving state tax money by providing tax information to schools and donors. They operate under the Educational Improvement Tax Credit Program (EITC) offered by the state of Pennsylvania.
